Warm welcome you all to the online training program on, **'Essential Elements of Research Methodology for the Professionals and Young Researchers**, conducted by the Bangladesh Institute of Governance and Management (BIGM), commissioned by the Social Science Research Council (SSRC), Planning Division, Ministry of Planning, Bangladesh. This training program is intended to be the first formal step of an ongoing process of learning and development, to launch and enhance the capacity of community-based researchers in a community-based participatory action research project during this pandemic situation.

This training course is designed to introduce graduate students and young researchers to the process of conducting scientific research in the field of social sciences, business, education and public health. It is a comprehensive and compact source for foundational concepts in conducting primary/micro research.

This programme will help participants to:

- 1. Get oriented with the concept of scientific research
- 2. Familiarize them with methodology, tools and techniques of research
- 3. Be acquainted with various stages and procedures of Academic Research
- 4. Be enriched with hands-on experience in conducting research to the participants

The course is divided broadly into three phases: The **First Phase** covers the theoretical aspects of research and research methodology; the **Second Phase** covers the practical experience of data collection through survey techniques (quantitative methods) and in-depth interview (qualitative method). Thereafter, participants themselves are engaged with the exercises of data entry and cleaning process and that data set used for analysis by different software. In the **Third Phase**, participants

focus on preparing research report, scientific journal publication process with referencing system (both manual and software). Finally, participants prepare reports through group activity and submit their reports. Successful completion/presentation of the report is mandatory to award the certificate.

RESOURCE PERSONS PROFILE

Dr. Krishna Gayen is Senior Research Fellow and Acting Additional Director (Research) of the Bangladesh Institute of Governance and Management (BIGM). She obtained her Bachelors and Masters in Statistics from Jahangir Nagar University in Bangladesh and did her PhD from Napier University in the UK. She joined the Bangladesh Civil Service in 1989 and



worked in the Rural and Co-operatives Division, Ministry of Agriculture, Planning Commission, Economic Relations Division, Finance Division, Financial Institutions Division, and the Information and Communication Technology Division of the Government in different capacities. As Additional Secretary to the Government, she served as the Director General of the Bangladesh Bureau of Statistics (BBS) from July 2018 to September 2019. Her research interests include official statistics, poverty, unemployment, and inequality.



Dr. Abdur Rahim Khan has been serving as Associate Professor of BIGM. He obtained B.S.S (Hons) and Masters of Social Science Social Welfare from University of Dhaka as top most student. He did his M.Sc in Development Economics from the University of Bradford, England as Commonwealth Scholar and did his PhD in Sociology as ICCR scholar from University of Pune,

India. He served in different capacities under Social Science Research Council for 33 years. After his retirement, Dr. Khan engaged himself in teaching at several universities as adjunct faculty. He has been teaching social science research methodology at the Bureau of Economic Research, University of Dhaka since 1990. He is a member of the Evaluation Committee and an appointed language reviewer of

Bangladesh Police Headquarter. A good number of his articles have been published by UNESCO and other reputed foreign publishers.

Dr. Md. Moniruzzaman is an Additional Secretary to the Govt. and currently working as the Director (Finance), Bangladesh Bridge Authority, Bridges Division. He completed his MSS in Economics from the University of Dhaka. He also did another Masters in Economics of Development from Australian National University, Australia with distinction.
